I, individually and/or on behalf of Minor Participant, further agree to **defend, indemnify and hold harmless the Released Parties** from and against any expenses, attorneys' fees, loss, liability, damages or cost they may incur arising from any claim or lawsuit brought against them for any injuries, wrongful death, losses or damages of any kind that have been released or discharged by this Release **whether caused in whole or in part by the NEGLIGENCE, STRICT LIABILITY or other FAULT (excluding gross negligence and intentional torts) of the Released Parties or any entity or person performing any function with respect to the Activities.** I, individually and/or on behalf of Minor Participant, understand and agree that this indemnity obligation includes any claims, actions, damages or lawsuits brought by me or by anyone else on my or Minor Participant's behalf, including those for personal injuries, illness or damage to or loss of real or personal property arising from my or Minor Participant's attendance or participation in the Activities. -

I, individually and/or on behalf of Minor Participant, hereby grant the Released Parties the irrevocable right and permission to photograph or otherwise record me or Minor Participant in connection with the Activities, and to use the photograph or recording ("Photograph") for all purposes, including advertising and promotional purposes, in any manner in any and all media now or hereafter known, in perpetuity throughout the world, without restriction as to alteration. I, individually and/or on behalf of Minor Participant, waive any right to inspect and approve the use of the Photograph, and acknowledge and agree that the rights granted by this Release are without compensation of any kind. I, individually and/or on behalf of Minor Participant acknowledge and agree that I have no right, title or interest in the Photographs and agree that such Photographs and the copyright therein are the exclusive property of the Released Parties. I, individually and/or on behalf of Minor Participant agree to release and discharge the Released Parties from any claims, actions, damages, demands, costs, expenses (including attorneys' fees) or lawsuits of any kind (excluding gross negligence or intentional torts) by reason of the sale, distribution or use of such Photographs.

I, individually and/or on behalf of Minor Participant, hereby understand that this Release is intended to be as broad and inclusive as permitted by Texas law, and that if any term or provision of this Release shall to any extent be held invalid or unenforceable, the remaining terms of the Release shall not be affected thereby, but shall be valid and enforceable to the fullest extent permitted by Texas law. The invalid provision shall automatically be replaced by a substitute provision which is valid and as nearly as possible maintains the same economic purposes and intention of the valid provision.

I, individually and/or on behalf of Minor Participant, acknowledge and agree that this Release shall be governed by the substantive provisions of Texas law, without reference to its principles of conflicts of law. Any claim or lawsuit brought to interpret or enforce the terms of this Release shall be brought in federal court in the district in which Bexar County is located or in the absence of federal court jurisdiction, in a state court of competent jurisdiction in Bexar County, Texas.

8. I, individually and/or on behalf of Minor Participant, agree that this Release shall be binding upon me, Minor Participant and our family members, legal representatives, executors, heirs, next of kin, successors, beneficiaries and assigns.
